## AN ANTHOLOGY OF HUNTER COLLEGE VERSE

If sufficient support shall be forthcoming—in the shape of advance subscriptions, or a guaranty fund, or both,— a volume with the above title will be issued, this season if possible, and sold for the benefit of one or

more of the College interests.

The tentative plans contemplate a book of octavo size, bound in boards, with approximately 150 pages of good paper. The contents will consist of poems by persons who have been connected with the College either as teachers or as students, though not necessarily written during their connection with it. Nor need the subjects refer in any way to the institution; the merit of the verses and their appropriateness for such a volume will be the main criteria for selection. It is, of course, desirable that as many writers as possible should be represented. Those who know the quality of the poetry written by some of our Alumnaeby Helen Gray Cone, Amelia Josephine Burr, J. A. Meyer, Mary C. Low, Jeannette Sewell Davis (not to mention many others) -will hardly doubt that such a volume may be made a great credit to the College. Quite apart from the expectation of pecuniary profit, it will secure "publicity" of the most appropriate and desirable kind.

A volume of this size would ordinarily sell at the present time for at least \$1.50. But in order to secure the widest distribution of this Anthology it is planned to fix its price at \$1.00 net. You are cordially invited to subscribe for one or more copies on these terms. As no bargain will be made with a printer until adequate support is secured, you are urged to send in your order at once. This project has been submitted to the Executive Committee of the Associate Alumnae and has received its approval. Professor Cone has generously consented to give counsel in editorial matters, though taking no responsibility for final decisions. obtain the privilege of morning classes, more than two hundred and fifty students, each personally interviewed by the Director, registered at the Bureau of Occupations, two weeks before the official opening of College. Special cards of registration were printed and issued by the Registrar's office in collaboration with the Bureau of Occupations, their object being two-fold, the prevention of the overcrowding of the morning classes and the investigation of the necessity for students' earning money. By their means the Director was also enabled to distinguish those compelled to work from those working for extra luxuries. It proved a very interesting and worth while experiment.

The plan to employ a Field Worker has been developed, and early in September we engaged the services of Miss Florence S. Hillebrand, a graduate of the New York School of Social Work, who has been canvassing the business world for Part Time Employment. Though it is a bit early to report concrete results, we feel the increased coöperation with employers has already compensated for the added expense of her salary.

This year we are to celebrate the FIFTH YEAR of the existence of the Bureau of Occupations, and we want every member of the Associate Alumnae to know about our work and the wonderful development of the Bureau.
