Mr. Li is President of the Chinese Y. M. C. A. of New York and vicinity. He will return to China this year to teach music in the Education Department of The University of Peiping.

GRADUATE GLEANINGS

Dr. Mary Ellen Meade, '18, was recently appointed principal of Tottenville High School, Staten Island. She is the first woman in the history of the New York City educational system to be named principal of a coeducational high school. Dr. Meade's experience and training fit her for this post. It is particularly fitting that a graduate of the largest woman's college in the world should win this honor.

Miss Meade, who was born on Staten Island, received her elementary education in New Jersey and on Staten Island. She attended Curtis High School, being graduated in 1914 at the age of fifteen. Four years later she was graduated from Hunter and "started immediately upon her teaching career at Curtis.

In College, although she majored in classics, she had become interested in history, and her teaching under the inspiring chairmanship of Mr. William W. Rogers, now principal of Theodore Roosevelt High School, deepened and matured this interest. She was granted her Master's degree by Columbia University in 1926, and in 1930 was appointed to Thomas Jefferson High School as First Assistant in History. After a year's service there she returned to Curtis in the same capacity. In 1935 she was granted her doctor's degree by Fordham University in the field of political philosophy, and since that time has continued her studies there and at New York University.

at New York University. Miss Meade's outstanding characteristics are her breadth of vision, her understanding sympathy, and her fine scholarship. These coupled with exceptional executive ability make her work as a teacher and director memorable.

Three of Dr. Meade's sisters are also Hunter alumnae and teachers in New York schools—Margaret C., president of the June 1920 class and a member of the Alumnae Executive Council; Anna M., '22; and Katherine S., '28.

Rose F. Netter, M. D., Hunter '24, Bellevue and New York University Medical College '28, has published an article in the *New York State Journal of Medicine* for December 1, 1936, on "Jaundice and Anemia with Recovery in Successive Newborn Siblings".

A number of graduates of the Biology Department have recently received honors.

The March issue of the American Journal of Botany contains the thesis of Dinah Marmer, '35, who has received her M. A. in Botany at Columbia. On the basis of her work in the field Miss Marmer was awarded a Curtis University Fellowship. At present she is well on her way to the completion of her Ph.D. thesis on "Plant Growth Hormones".

A Grant-in-Aid has been awarded to Selma Epstein, '36, for work in Zoology at Columbia.

Marjorie Greene has received an appoint-

ment at the University of Maine. She worked at Radcliffe, on a teaching fellowship, for six months before receiving her present position.

A teaching fellowship at New York University has been given to Ethel Poris, '35. Her Ph.D. thesis will concern the pituitary function and cell types in amphibia and reptiles. While at Hunter, Miss Poris was the recipient of both the Kane Gold Medal and the Woods Hole Scholarship.

Frances Johnston, '37, was recently appointed to the laboratory of St. Vincent's Hospital at Staten Island.

Virginia Costadosi, January '36, has been awarded the scholarship of the Institute of International Education.

The scholarship provides a year in Italy, during which Miss Costadosi will teach, study, and travel.

She is a member of Phi Beta Kappa, and in her senior year served as Chairman of the Judicial Board.

The Henry Bargy Memorial Scholarship in French, given annually to a graduate of Hunter College engaged in teaching languages, has been awarded to Miss Nettie Laminsky.

The Bargy Scholarship provides \$450.00, to be used for a summer of travel and study in France.
