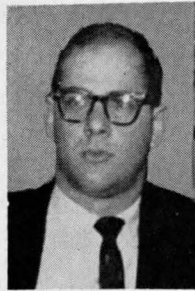


New Board of Directors

MORTON BERKOWITZ
