AN APPEAL FOR AID

To the Alumnae:—

Some years ago, before the Bureau of Occupations became part of the College, Mrs. Ottenberg used to bring the report of the activities of the Bureau to you, its sponsors and most generous supporters. At all times you evinced the keenest interest in its progress, and now, being faced with another problem, we again turn to you to help us solve it.

In order to enable college students of good character and scholarship to complete their college course, the National Government has issued a grant for needy students, which is part of the Federal Emergency Relief Project. 12% of the entire college enrollment may be delegated to useful work, either within the college walls or outside, in social, philanthropic, or educational institutions. For this, the Government pays at the rate of not more than \$.50 an hour or less than \$.30. Almost six hundred students are already on our payroll earning about \$15.00 a month, and more are waiting to be enrolled.

Here is our problem: to be absolutely sure that only the most needy are receiving aid, it is necessary to make a social investigation of each home, for which task there is no machinery at College. Knowing of your interest in the students and your desire to be of service, both Dean Egan and I thought and hoped that some members of the association might volunteer to make these social investigations until such a time as all these homes shall have been visited. The requisites for the investigators are these: some leisure, a sympathetic understanding, good judgment, and physical strength to climb stairs.

We would welcome the names of as many volunteers as possible, for the more at work, the sooner the task can be completed. The Bureau of Occupations stands ready to advise and to make the task as light as possible.

If you are in sympathy with the work and can volunteer, will you send your names and addresses to me at Hunter College as soon as possible?
